

## **Grants Committee and Grant Process**

Revised 8/12/2023

## Assumptions

- The Grants Committee will be tasked with ensuring we are funding requests that align with the stated foci (pillars) established by the Diocesan Council and the Standing Committee.
- Creating a centralized Grants Committee allows for consistency and equity across the diocese as part of our overall mission and vision
- Ensures timely follow up from the Grants Committee to the requestor on additional questions or information the Grants Committee has for the requestor.
- Will provide transparency and consistent communication to the Diocesan community about who received a grant, what the grant is for, and how much money was received.
  - Reporting to Diocesan Council and the Standing Committee after each granting cycle
  - Reporting to the Diocesan community in the New Spirit
  - Information on grant requests received and approved will become part of the information contained in the Journal of Convention

## Members of the Grants Committee

Elected by each deanery: 1 lay and 1 clergy member from NW Metro Deanery

1 lay and 1 clergy member Central Deanery

1 lay and 1 clergy member Southern Deanery

(please note that the Deans are eligible for election)

- Member of the Property Committee
- Treasurer
- Finance Director
- Vice President of Diocesan Council
- Member of the Standing Committee
- Chancellor as needed

## **Grants Committee and Grant Process**

Revised 8/12/2023

## Process and Timeline

- The Grants Committee will meet as often as monthly (they will not meet when there are no grant requests)
- Grant requests will be due on the 1<sup>st</sup> Tuesday of each month, sent to a Diocesan email address for the Grants Committee.
  - ♦ The chair (to be elected by the committee) will receive and review the grant request
    - If the request is not complete or unclear, the chair will send an email to the requestor asking for more information or asking clarifying questions
  - ♦ The Bishop's Executive Assistant will distribute the requests to the committee members along with the zoom link for the Grant Committee Meeting.
  - ♦ The Grants Committee will meet on 3<sup>rd</sup> Tuesday of each month to review the Grant Requests.
    - If extra information is determined to be needed, that information will be requested immediately following the Grants Committee meeting by the Committee secretary (to be elected by the committee).
    - If no extra information is required, the secretary will send a letter with the disposition of the Grant request to the requestor, with a cc to the Finance Director and the Bishop.
  - A copy of the grant request, the worksheet the Grant Committee completed, a copy of the check (if approved) and the letter to the requestor will be incorporated into the file of the congregation or entity requesting a grant.

# Grants Committee and Grant Process

  - ♦ Title of Project
  - Amount requested
  - Which Pillar the grant request falls under
    - Practicing God's Economy
    - Striving for Justice
    - Forming Disciples
    - Proclaiming the Good News
    - Serving Others
    - Administration
  - Detailed explanation of the grant request
    - Including why it supports the particular pillar
  - Submission of 3 bids (if applicable) to support the grant request (depending upon the nature of the grant, 3 bids may not be necessary)
  - Contributions by the congregation or entity to this project/request
    - Monetary commitment
    - In-kind commitment
  - IF APPLICABLE: Are there other congregations around you working on similar projects? What are your commitments to each other to collaborate?
- FOR THE GRANTS COMMITTEE:
  - Prioritize grants from multiple churches working together
  - Ensure each deanery is treated equally and fairly in the granting process
  - Projects that have received grant funding in previous years may be, but not MUST be, evaluated as a lower priority.
- Develop a worksheet for the Grants Committee to use:
  - ♦ Date
  - ♦ Title of Project
  - Congregation or Entity
  - ♦ Requested amount
  - Is the request being made clear?
    - If it is not clear, what additional information is necessary?
  - Does it support the pillar under which it is being requested?
    - Yes or No
      - Hands on (pillar-related) ministries take precedence. Does this request address any of the pillars or is it "outside the box?"
  - Recommendation of the Committee:
    - Grant at full request
    - Grant at a lesser amount \_\_\_\_\_

- 5. with seat, voice, and vote, unless otherwise noted:
- (a) The Bishop;
- (b) The Bishop Coadjutor, if any;
- (c) The Bishop Suffragan, if any;
- (d) The Archdeacon, if any;
- (e) Every cleric in good standing in the Church who is canonically
- 11. resident in this Diocese;
- (f) The Secretary of the Diocese;
- 13. (g) The Treasurer of the Diocese;
- 14. (h) The Chancellor of the Diocese (seat and voice, but no vote);
- (i) Any other Officers of the Diocese, if any (seat and voice, but no vote);
- (i) Lay delegates from every Parish and Congregation in union with
- 17. the Diocese duly chosen and entitled to seats, as hereinafter provided.

#### Explanation:

This amendment would convert the Chancellor into a non-voting member of the Convention. The Chancellor is the chief legal officer of the Diocese. As such, the Chancellor provides legal advice and counsel to the Diocese and its components, including the Convention. As a voting member of the Convention, the Chancellor could cast a vote on a matter on which they also provided legal advice. By doing so, the attorney-client privilege and attorney work product doctrine that attach to legal advice could be jeopardized, thus potentially putting the Diocese in a bad position. While perhaps remote, having a non-voting Chancellor would be a best practice and would conform with how a majority of dioceses treat this issue.

This amendment would also convert the Registrar and Vice Chancellor into non-voting positions, as well as make the Associate Treasurer a non-voting member of the Convention.

This is the first reading of an amendment to the Constitution. A second reading will be necessary at the next Diocesan Convention, with a vote by orders necessary to adopt the change at that Convention.

#### Explanation

This resolution is an expansion of 2018 General Convention Resolution 2018-A010: The Planting of "Paris Groves."

Trees provide beauty and biodiversity to the earth, shade for humans, homes for animals and birds, increase property value up to 20%, reduce crime rates, reduce storm-water runoff, filter air pollutants, and reduce pulmonary health cases such as asthma.

Swiss scientists say the most effective way to counter global warming is to plant lots of trees. A trillion of them around the world. Those same scientists say even with existing cities and farmland, there is enough space for new trees to cover 3.5 million square miles. That is roughly the size of the United States. Their study calculated that over the decades, those new trees and shrubs could suck up nearly 830 billion tons of heat-trapping carbon dioxide from the atmosphere. That is approximately as much carbon pollution as humans have spewed in the past 25 years. Thomas Crowther, a climate change ecologist with the Swiss

Federal Institute of Technology in Zurich, says, "This is by far-by thousands- the cheapest climate change solution." Thomas Lovejoy, a George Mason University conservation biologist who was not part of the Swiss study, called it "a good news story" because planting trees would also help stem the loss of biodiversity <sup>2</sup>

Jack Cobb, Director of the Office of Global Relations, works together with The Episcopal Church's Representatives at the United Nations, where they advocate on the international level at the UN to address climate change. They participate in the United National Framework Convention on Climate Change (UNFCCC) at the Conference of Parties (CoP), an annual intergovernmental meeting focused on global dialogue and action on climate issues. The Office of Governmental Relations supports Resolution A010.

The proposers believe that communities and civic groups would appreciate the donation and planting of trees, shrubs, and grasses in parks and other public spaces. The proposers are confident that each congregation has the expertise and community connections to carry out planting of "Paris Groves-A Creation Care Ministry."

#### Explanation

Canon III.11.1.a of The Episcopal Church and Article IV.1 of the Constitution of the Diocese of West Missouri give the diocesan Standing Committee oversight and responsibility for the election of a Bishop Diocesan. In April 2023, the Standing Committee met with the Rt. Rev. Todd Ousley, bishop for pastoral development in the Office of the Presiding Bishop, to discern the diocese's readiness to begin searching for the ninth bishop of West Missouri, and the committee voted to launch that process. In May 2023, the Standing Committee voted that the diocese would contract with the Rev. Canon Brian Nordwick as our search consultant, one of three potential consultants offered by Bishop Ousley and interviewed by the Standing Committee. In July, assisted by Canon Nordwick, the Standing Committee began organizing the search process, drafting job descriptions for members of three searchrelated committees (Bishop Search, Transition, and Consecration) and a search chaplain, as well as a timeline for the search-to-consecration process and a prayer for the process. In August, the Standing Committee approved these documents and created a search website, assisted by Zach Phillips, diocesan communications director. The search website came online Aug. 23 with applications for the Bishop Search Committee, Transition Committee, and Consecration Committee. An email was sent to the diocesan community on Aug. 24 inviting applications, and another email was sent Sept. 28 reminding the diocesan community of the application deadline, Oct. 1. With this resolution, the Diocesan Convention will authorize the process for searching for, electing, and consecrating the ninth bishop of West Missouri.

#### Explanation

The University of the South, familiarly known as Sewanee, was founded in 1858 by several dioceses of the Episcopal Church and was intended to be owned and governed by the Church. The Diocese of West Missouri benefits greatly from the work of the University. Many of our high school students have gone on to attend its College of Arts & Sciences, many of our clergy have been formed at its School of Theology, and a significant percentage of the Diocese has participated in Education for Ministry (EfM), a ministry of the University.

Becoming a Constituent Diocese would allow us representation on the University's Board of Trustees, giving us a say in the governance of an institution with which we are already in a relationship.

Should this resolution pass, it would be incumbent upon the University's Board of Trustees to decide to extend an invitation to our Diocese to enter into a constituent relationship. Diocesan contributions from constituent dioceses to Sewanee range widely, currently from \$0 - \$20,000, the average being \$3,000. This resolution would have no budgetary impact on the 2024-2025 Plan for Ministry.

Likewise, nearby dioceses, including West Missouri's partners in the Bishop Kemper School for Ministry (Missouri, Kansas, Western Kansas, Oklahoma, and Iowa), allow deacons to serve on their Standing Committees. Most importantly, Standing Committee is responsible for serving as the Bishop's Council of Advice and as the Ecclesiastical Authority in the absence of a Bishop. The perspectives of deacons should be available to Standing Committee's work in these roles. This constitutional change would not mandate the presence of deacons on Standing Committee; it would only allow deacons to seek election to Standing Committee (or be eligible for appointment in the event of a clergy vacancy).


