

## What are the highlights of your ministry for 2023?

- In February 2023, the DBEC was asked to evaluate the GOE responses of Jody Carroll, David Wilcox and Ryan Zavacky, candidates for ordination to the transitional diaconate and subsequently to the priesthood. The responses from the members of the Board were unanimously supportive and judged their responses to be proficient in all areas of the canonical exam. The recommendation was made that they be ordained to Holy Orders.
- In February 2023, the DBEC administered a written canonical exam to Robin Rusconi, a candidate for ordination to the vocational diaconate. The unanimous evaluation of the Board is that she provided satisfactory responses to all areas of these exam questions. They recommended that she be ordained to Holy Orders.

### What are your plans for ministry in 2024?

- The Board will continue to refine and update its examination questions for deacon candidates to better gauge their competencies and make the questions timely.
- Coordinate with the Bishop Kemper School for Ministry on the examination of their students and seek ways to share ideas with Examiners in other Dioceses. At this point, DBEC members Bill Stancil and Victor Matthews are teaching courses at BKSM and are gaining a better sense of the skill levels of the candidates.
- Continue to coordinate with the Commission on Ministry as part of the discernment process for ministry.

• The Board Chair will continue to serve as ex-officio member of the Commission on Ministry and to make reports at their meetings.

# 2. PEACE AND JUSTICE COMMITTEE

The Peace and Justice Committee has now reached it's one year mark of existence after Bishop Bruce created the committee and asked it to focus initially on Gun Violence and secondarily on a response to the Dobbs decision. The committee met monthly for the past year.

The committee decided to focus first on the issue of children and guns, using the Be SMART for Kids program developed by Everytown for Gun Safety. This program is a non-political education and resource program for adults about keeping guns out of the hands of children to prevent unintentional shootings and youth suicide. The committee developed a communications toolkit for churches, with multiple delivery methods of the information, including social media graphics, handouts, information on sharing the message at Trunk or Treats, and a 20 minute powerful presentation to adult forums and other church groups. Multiple committee members went through Be SMART presenter training and gave their first presentations.

A series of articles explaining the Be SMART message and the Bishop's focus on Gun Violence appeared in the New Spirit and were re-shared by many churches within the diocese. Diocesan Communications staff also shared many of the social media graphics and other articles about Gun Violence.

The Peace and Justice Committee of The Diocese of West Missouri is working jointly with the Missioner for Gun Violence in the Diocese of Missouri with a shared logo and activities. In March, over 30 Episcopalians from across the state joined Moms Demand Action for Gun Sense in America for their Advocacy Day in Jefferson City to advocate for common sense gun laws. Before meeting with lawmakers, the Episcopalians processed behind a banner to the steps of the Capitol and leaders from both dioceses led a short prayer service on the steps of the Missouri State Capitol building.

On Sunday, June 4, Bishop Bruce invited all churches within the Diocese to observe Wear Orange Sunday, in recognition of victims and survivors of Gun Violence. Churches were provided with Prayers of the People and other prayers that they could choose to incorporate into their services, parishioners were asked to Wear Orange to church, and many clergy wore orange vestments. Some churches even had orange flowers on their altars. Many churches across the diocese participated.

The Peace and Justice Committee has formed a relationship with the Lutheran Synod and they are invited to join in all activities to address Gun Violence, with shared training, materials and activities.

The Diocese of Missouri is a party to the separation of church and state lawsuit opposing the Missouri trigger law after the Dobbs decision overturning Roe v. Wade. A member of the Peace and Justice Committee is a participant in the consortium of churches and religious organizations to keep the Diocese informed as to what is happening with this lawsuit, but The Diocese of West Missouri itself is not a party to the lawsuit.

In the next year we will continue to expand and present the Be SMART program throughout the diocese, with an emphasis on spreading it outside of the Kansas City region. We will again participate in Advocacy Day and invite more Episcopalians to join in advocating for common sense gun legislation, and will run a targeted letter writing campaign to leaders in the Missouri legislature to ask for gun safety bills to be heard in committee. We will again invite churches to participate in Wear Orange the first Sunday in June, and hope to have a Diocesan Gun Violence Victim memorial service that weekend for the community.

# 3. ST. LUKE'S NURSING CENTER, CARTHAGE, MISSOURI

St. Luke's Nursing Center (Carthage) Board of Directors met monthly throughout the year of 2022-2023. The board will continue to meet monthly for 2024. St. Luke's – Carthage employs approximately 107 employees and has a stable census of 72 residents in skilled nursing and 23 residents in assisted living.

The highlights of our ministry for 2023 included securing funds through community and foundation grants to purchase necessary medical equipment, complete and art project in which photographs of varying interests were hung on the walls of memory care, a sensory garden was planted and enjoyed by all the residents and, as they were able, some of them maintained the garden, along with much needed maintenance projects.

Plans for 2024 are reflected in the Board's Mission Statement: "Our St. Luke's community of care strives to show the healing presence of God through exceptional care for the mind, body, and spirit of our residents. When these are present, there are no limits to which can be accomplished." The Board of Directors will continue to move forward to maintain and improve the physical structure of our building (built in the 1970s) as we have funds available. The improvements include, but are not limited to, cosmetic solutions both to the inside and outside of the building. These improvements will make it possible to attract future residents by providing a newer look.

#### 4. DIOCESAN ARCHIVES

During the past year, I have made monthly trips to the archives to work on the organization of the collection. To date, the following actions have been completed:

- 24 additional shelves have been added to provide space for expansion
- The entire collection has been reorganized to reflect the organizational scheme provided by the National Archives of the Episcopal Church
- An in-depth inventory (Finding Aid) at the folder level of each box has begun. This Finding Aid will be uploaded to the new diocesan website and updated on a regular basis.
- Multiple questions and research assistance has been provided for individuals and diocesan groups. (Please note that the archives are not a lending collection, but we are happy to make copies of documents in the collection for researchers and organizations/churches of the diocese).

Going forward, the work on the Finding Aid will continue, along with appropriate re-housing of materials as they are encountered in this process. As mentioned, periodically, this information will be updated on the diocesan website to provide intellectual access to the collection.

# 5. THE ORDER OF THE DAUGHTERS OF THE KING

## How many meetings were held?

We don't track the number of meetings held, but each chapter usually meets once a month. With that in mind, the estimated number of chapter meetings held for The Order of the Daughters of the King in our diocese is approximately 150. Additionally, there were two diocesan assemblies held and a diocesan board retreat during the year.

## What are the highlights of your ministry for 2023?

- Held our first co-hosted Spring Assembly in Springfield in April at Christ Church
  with the Rev. Joanna Seibert from the Diocese of Arkansas as our speaker. We had
  an outstanding turnout of daughters who heard her speak on Forgiveness and the
  Spirituality of Aging.
- Made plans for our co-hosted Fall Assembly at Trinity Episcopal in Independence for October 21, 2023. It will be the election and installation of new officers for 2024-2027
- Sent a \$500 donation to Malawi to assist the daughters chapter that was literally wiped out by a cyclone. Our Province coupled their \$1000 donation with ours for added assistance.
- Sent a \$500 donation to be divided among our 4 national funds in compliance with our vows as daughters.
- Assisted our daughters in the diocese who required financial help in paying their national dues.
- Continued the work of bringing new members into the daughters chapters in the diocese.
- The diocese was represented at our Province VII Spring Assembly held in Dallas, Texas by a member of the Executive Committee.
- Offered \$50 grants to each chapter in the diocese in support of outreach entities they support in their communities.
- Explored new ideas for continued growth of Daughters of the King within our Diocese.
- Daughters continued to be faithful in their rule of life by praying daily for their parishes, dioceses and provinces, as well as national and international daughters.

Describe how these activities have furthered the work of the diocese and strengthened the parishes.

- Daughters of the King provide spiritual formation for the parish through their commitment to prayer, service and evangelism.
- Daughters are a rich resource to the priests of each parish where a Daughters of the King chapter is located.
- Daughters often attract new members through their external/internal evangelism and service which strengthens the parish as well as the diocese.

# What are your plans for ministry in 2024?

- Continue to seek opportunities for new chapters of Daughters of the King throughout the diocese. There are several parishes interested.
- Provide relevant and meaningful education that will nurture daughters for the furthering of God's Kingdom.
- Listen intently to the needs of daughters in the diocese and take direction from their input.
- Actively participate in the selection process for our new bishop, as is appropriate.

#### How will you measure success in 2024?

- Track (through our national office) new member numbers, which are only reported to the diocesan level once every three years.
- Within the diocese, track interest in new chapters and applications for membership.
- Follow the involvement of Daughters in reported participation within the life of their respective parishes. Chapter presidents report this information to the President of the Diocese once a year.
- Utilize our diocese membership chair to work closely with those chapters who experience issues in dues payment annually.

#### How does your ministry reflect the priorities of the diocese?

#### A. Grow Congregations:

• The presence of Daughters of the King Chapters within a parish helps stabilize and sustain the parish so the church can grow and ministry can be on-going.

#### **B. Grow Personally:**

• Daughters grow personally through practicing their Rule of Life: to pray, to serve and to evangelize in furthering the Kingdom of God.

#### **C. Grow in Community:**

• The activities of the individual Chapters of Daughters of the King represent the accounting of the work carried out in communities, often hand-in-hand with other community partners.

#### **D. Grow in Compassion:**

- Daughters recognize the need to aid others, as is seen time and time again, in the work they do throughout the diocese. Service is one of the rules daughters vow to uphold in becoming a member of the order.
- Daughters wear their crosses daily and hold each other accountable in an effort to show the world who we are and to whom we belong.

#### E. Grow Leaders:

- Through prayer, service to others and evangelism, many daughters have found their role as leaders within their parish, the diocese, the province and even at the national level.
- We nurture chapter members in leadership so the future of Daughters of the King in the Diocese will be on-going for years to come.
- Continue to provide a retreat every 2-3 years for the chapter presidents to assist in their growth of Daughters of the King within our diocese.

#### 2023

The Heartland Episcopal Cursillo Secretariat has spent 2023 discussing and planning how we can re-energize the Cursillo Ministry in a post-pandemic Christian world. We have already met either in-person or by Zoom 10 times in 2023 with more meetings planned for the balance of the year. We had a Zoom Meeting with the President of the National Episcopal Cursillo, Rob Richardson, to discuss what other Cursillo Diocesans have done to succeed or fail post-pandemic. Our Cursillo Diocese, comprising of Western Missouri and Eastern Kansas, covers the largest area compared to other Cursillo Dioceses with a population that is spread out over several metropolitan areas. This is the source of some of the problems that the Secretariat is trying to resolve in order to re-energize our ministry. We have a call scheduled in October with Bishop Diane M. Jardine Bruce and Bishop Cathleen Bascom to ask for their help in getting our word out to all the parishes.

During 2023, we have held three Quarterly Ultreyas – St. Peters & All Saints, St. Thomas the Apostle, and Church of the Good Shephard – with our 4<sup>th</sup> Quarter Ultreya to be held at St. Mary's. We are also planning a Grand Ultreya during the month of November.

#### 2024

For 2024, we are planning on having our first Cursillo Weekend since 2019 due to the pandemic. In addition, we will have our four Quarterly Ultreyas and one Grand Ultreya in 2024.

The Secretariat will be meeting every month in 2024 to further discuss ways to energize our ministry and strategizing for the future along with expanding the Secretariat members to include more representatives from other Heartland Diocese Parishes.

# 10. COMMISSION ON MINISTRY

The Commission on Ministry (COM) exists in compliance with Title III, Canon 2 of the Canons and Constitutions as an advisory role to the bishop in the implementation of Title III. The primary responsibilities are the encouraging and enabling present and future opportunities for the ministry of all the baptized, in the design and oversight of recruitment, discernment, formation for ministry and assisting in assessing individuals' readiness for ministry.

Our Subcommittees have been formed to cover these areas articulated in specific Canons under Title III. These four subcommittees are Discernment, Ordination Process, Licensed Ministry, and Clergy Continuing Education, Orientation and Mentoring. Membership in these subcommittees is not limited to members of the Commission. The chairs of the subcommittees will be ex-officio members of the Commission, if not already elected or appointed members.

During 2023 we returned to in-person meetings with the additional flexibility that we included participation via Zoom. COM began scheduling monthly meetings. COM also held two Saturday retreats; one in February 2023 and one July 2023 as a Day of Discernment for nominees and interested individuals.

# 11. DIVERSITY AND RECONCILIATION COMMISSION



Many of the hymns in the Hymnal 1982 have very interesting histories. However, hymn 599 stands out as one that embodies the history of African American people.

You see, hymn 599 in the Episcopal Hymnal is considered the Black National Anthem. The National Association for the Advancement of Colored People (NAACP) proclaimed it so in 1920. My surprise to see that it was included in the Episcopal Hymnal was acute, but my disappointment at realizing that the vast majority of white Episcopalians were unaware of the importance of this hymn to their African American congregants is very real.

We held two workshops: One at St. Phillips, Joplin on April 29,2023 and the second one at Grace, Liberty on September 16, 2023.



There were twenty-seven participants.




There are twenty-nine registered.

#### Juneteenth became an official federal holiday


June 18, 2023: Service held at St. Augustine's Episcopal Church


Juneteenth is the oldest nationally celebrated commemoration of the ending of slavery in the United States. Originating in Galveston, Texas, it commemorates the announcement on June 19, 1865, of <u>General Order No. 3</u> by Union Army General Gordon Granger, proclaiming freedom from slavery in Texas. Today Juneteenth commemorates African American freedom and emphasizes education and achievement.



On Monday, June 19, the Diversity and Reconciliation Commission of The Diocese of West Missouri invites anyone able to embark upon a pilgrimage to Park Central Square, Springfield, Missouri, the site of the April 1906 lynching of three African American men, Horace Duncan, Fred Coker, and William Allen.

The event was held at Park Central Square in Springfield with over a hundred people in attendance. A bus from Kansas City had some forty people take the trip to Springfield.





The Beloved Community of Care and Love Book Club read and discussed two books in 2023.





"Firearms are now the leading cause of death among children in the United States, but these tragedies are preventable. The Be SMART campaign was launched in 2015 to promote responsible gun ownership to reduce the deaths, injuries and trauma that can result when a child or teen can access a gun. Since then, Be SMART volunteers have encouraged community leaders to come together to emphasize the importance of gun safety and the everyday actions we can take to keep guns out of the hands of kids."

The Diversity Commission is working with the Peace and Justice Committee on gun safety in our community. Members of the Peace and Justice Committee have been trained on the Be Smart Program. The Be Smart Program works with the churches and communities on how to handle a gun and they provide locks for weapons that are in homes.

The Episcopal Church of the Good Shepherd on Sunday, September 17 for a Be SMART Lunch and Learn. The speaker will be a representative from Be SMART, which is a volunteer group focused on gun safety and children.

# Highlights

- The biggest highlight for the Communications Committee is that we have been in the process of building a new website and are expected to launch beginning of November. This new website will migrate the three current sites into one central hub, which will effectively eliminate the Spirit and Office sites.
- Along with the new website, there has been an ongoing process of rebranding.
   The Diocese of West Missouri is shifting from The Episcopal Church logo and

name, to just "The Diocese of West Missouri". This new branding includes a monochrome version of our seal that will be used across other marketing materials. These marketing materials that are done or in the process of being redone are:

- The social media strategy has been updated to an image heavy-based approach, rather than a text or graphic-heavy approach. This change has been effective since June 1 of this year. Since then, we've seen steady growth on our platforms compared to the previous 3 months (Feb May).

# 13. BISHOP KEMPER SCHOOL FOR MINISTRY

#### Highlights of the Previous Year

On June 30, 2023 BKSM finished its  $10^{th}$  year of operation! We continue to ponder what kind of institution we have become and what core values will continue to guide us. We have so much to give thanks for!

- Last May's commencement was a very joyous celebration of our first decade, with the Right Reverend Scott Barker as our principal speaker. We wonder what the next decade will bring!
- Last spring the Diocese of Iowa became our sixth partnering diocese, joining the four original members--Kansas, Nebraska, West Missouri and Western Kansas—and Missouri, who joined us in the fall of 2022. We do not anticipate further expansion. It seems meet and right to serve the Episcopal Church in all of the four central states of the US. We value community so much that we do not wish to become a school devoted exclusively to distance learning. With six dioceses we have much stability, a wealth of human resources, and rich interactions between a variety of contexts for mission.
- After reaching our highest enrollments yet the previous two years, this fall we've returned to our usual level of just over 30 students pursuing certificates of study. 7 are from WMO (3 presbyteral, 3 diaconal, 1 lay). We're very grateful that we built the school to avoid being tuition driven. The consistent financial support of our sponsoring dioceses is such a blessing, providing for all necessary overhead with great regularity. This is especially appreciated in times of inflation. BKSM continues to be affordable and accessible to everyone.
- Recent developments have given us a better sense of our place in the emerging ecology of theological education in the Episcopal Church. CDSP ended its residential program, EDS is exploring new directions, and Yale Berkeley just announced an expansion of its online and distance learning programs. Evidently we have been on the cutting edge of larger trends. Moreover, a team of three from BKSM was invited to participate in a conference on bi-vocational ministry held at Camp Allen last summer, funded by the Lilly Endowment. Schools like ours are emerging all over the church. These programs demonstrate the kind collegial spirit that has characterized BKSM from the beginning. In "local formation" students form lasting, supportive friendships across diocesan lines and orders. Together we have developed a culture that cherishes all relationships and welcomes the gifts of each and every one. We are very excited to be part of this larger enterprise.
- With the leadership of Brother James Dowd of the Benedictine Way, we continue to weave sound spirituality into all aspects of our life together. In the summer of 2023 we added a third retreat for students entering their final year. New students continue to write a rule of life that will be followed throughout their time of common study. Students regularly pray for each other. We have begun to observe times of silence

during our focus weekends.

- We strive to always focus on the core mission of the Episcopal Church. Thanks to the generous offering by the Diocese of West Missouri students were able to participate in the course on the Doctrine of Discovery for the first time. Topics in racial and ethnic diversity are included in courses across our curriculum, and are regularly the focus of our evening zoom sessions in between monthly focus sessions. We observed the month devoted to creation care with a special Eucharist. Archdeacon Betsy Bennett offered a stirring homily. The opening of Bethany Gardens next to our campus in Topeka offers a great setting for consideration of our responsibilities to care for the earth. We have strengthened our course work in evangelism and encourage students to design practical projects that reach out to potential new members.
- While we were very sorry to lose him to our diocese, Rev. Charles Everson's move to an important parish in the Diocese of Chicago represented a milestone in the church's acceptance of capable graduates of our school in a variety or roles.

#### Plans for the Coming Year

- Next June Dean Don Compier will complete his 10th year as the dean. Serving in this role, with the collaboration of so many creative and collegial people, has been the best part of his academic career, which will surely end with his term at BKSM. But, God willing, not quite yet!
- We are increasing our efforts to attract more lay students. Their equal presence in the mix is vital to the future of sustainable bi-vocational ministry.
- The recording of WMO's class on the Doctrine of Discovery will be used in facilitated discussions with students who were not able to attend, allowing them to complete this important requirement.

We cannot adequately express our deep gratitude to the people of the diocese of West Missouri. The devotion and the rich human resources that you so generously share are blessing the Episcopal Church throughout the Midwest.

# 14. EPISCOPAL VETERANS FELLOWSHIP OF WEST MISSOURI

Formed in the Spring of this year, Bishop Bruce convened myself, the Rev. Adam James, Northwest-Metro Deanery, Susan Eveland, Central Deanery, and Todd Wilkinson, Southern Deanery, to comply with the 2019 Diocesan Resolution. We met monthly to discern our identity within the diocese's relationship to the greater Episcopal Veterans Fellowship of The Episcopal Church.

After conversations with the founder of the EVF and the current president, we felt called to widen the ministry to include other service-oriented individuals who have experienced similar moral wounds as veterans. First responders, front-line responders, healthcare providers, caregivers, teachers, and school administrators have all been welcome to participate in our diocesan EVF. Individuals who have experienced violence in the workplace setting and have suffered, or those who care for someone who has suffered, have become the benchmark for our ministry's identity.

In July, our diocesan EVF embarked on a five-week book study of The Rev. David Peters' "The Post Traumatic God: How The Church Cares for People Who Have Been to Hell and Back." Using Zoom to gather virtually across the diocese, we met each Monday night to discuss a portion of the book, how our personal experiences have informed us, and how we can use the theological writings of Paul Tillich to inform us on how to minister to others who have suffered the war-like effects of violence. During the five-week study, friendships were formed, and the Holy Spirit was present with us and guided us toward a larger vision of future ministry.

We are challenged by physical distance and must discern how to overcome this obstacle. A hybrid in-person/virtual meeting is planned for early October to continue the discussion on the future ministry activities of our diocesan EVF.

For 2024, our diocesan EVF will continue discernment for how we minister to those who have suffered the effects of war-like violence while serving our country, state, municipal, or civic institutions. An amendment to the original 2019 resolution will likely be needed to represent our ministry truly. Additionally, creating awareness through presentations to each deanery council and administering informational documents to each parish will be planned. Members are enthusiastic to reach others silently suffering, and making identifying name badges has been discussed.

  - Pastor interacting with the larger community to assist the church in meeting the needs of the community
  - Encouraging members to participate in outreach, mission, evangelism, and service beyond the doors of the church
  - Pastor/Teacher providing opportunities for learning and spiritual growth through
  - Spiritual Retreats, Marriage Retreats, and other activities open to Spanish
  - Speakers in the diocese and beyond its borders.
- 2. Consultant to diocesan churches, deaneries and groups exploring or implementing church plants, services and programs for Spanish speakers
- 3. Missioner will network with other clergy within and outside the diocese to develop programs and deliver services for Spanish speakers.

- Celebrated Las Posadas involving services and food in different homes and the church in both Carthage and Noel.
- o Guadalupe festival in December hosted Spanish and English speakers.
- o Kermess in Noel, a variant of street fair, raised the profile of the congregation in this small, almost entirely immigrant, town.
- Quinceaneras (large 15th birthday festivities) in Noel, Carthage and Kansas City.
- o Re-establish the Latino Ministry Committee.
- Working with the Latino Ministry Committee, consult with Diocesan churches, Deaneries or groups in the development of strategic plans for expanding Latino ministry in existing English Speaking congregations.
- o Continue developing retreat and formation opportunities for neighboring clergy and lay leaders.

#### 3. Outreach

- Extend the Gospel to the entire Hispanic Community. Visits to hospitals in the area, including in
- NW Arkansas. Help with parishioner going through naturalization process as a citizen.
- Adoration, Evangelism, Leadership, Stewardship, Pastoral Service, Bible Studies and Parish Community.

### 16. DEANS OF THE DIOCESE

Your Deans sit on the Episcopal Ministry Support Team, Diocesan Council, and Finance Committee in their roles as Deans of the Northwest-Metro, Southern, and Central deaneries. These three entities typically meet monthly. Each also sits on several other committees of diocese, participating throughout the year in the important work of the wider Diocese.

Each Dean has hosted Deanery Clericus and Deanery Council meetings throughout the year, as often as every other month, to keep Deanery Councils actively involved in the budget process for the 2024 Plan for Ministry. This process has been far more extensive in 2023 than in recent years.

Each deanery hosted a picnic during the month of July, braving hot and sometimes severe weather. Good food, good fun, good fellowship had by all who were able to attend! The 2024 deanery picnics have tentatively been scheduled for September in the hope of milder and cooler weather!

Deaneries have again in 2023 granted up to \$25,000 per deanery to support various outreach ministries and mission initiatives within the respective deaneries. While it is proposed to change the structure of the grants process for 2024, deaneries will still have significant input in the grants process.

Each of the current Deans was elected early in 2022 to fill the terms of the sitting deans, making each eligible for re-election for two full two-year terms. Each has agreed to stand for re-election in October.

We look forward to continuing to serve the Diocese and our respective deaneries.

## 2023 Ministry Highlights

- Commission members planned and submitted a Young Adult and Campus Ministry grant application with the national Episcopal Church last November. Though our request was not selected for funding, the planning process for grant writing played an important role in discerning new goals and projects for 2023.
- One of the proposed grant projects was the production of a podcast (*All Things...Episcopal*) which would serve as an introduction to the Episcopal church, especially targeting young adults and seekers new to our denomination. The podcast was officially launched in April and is hosted by Fr. David Kendrick, Fr. Collin Larimore, and Clare Stern-Burbano. Guests have included young adults currently active in our diocesan parishes. The first season of ten episodes was successfully completed this summer and featured a special closing conversation with Rt. Rev. Diane Jardine Bruce.
- *All Things...Episcopal* has been reaching a wide audience. There have been over 870 downloads of podcast episodes, reaching as far away as the United Kingdom, Greece, Canada, and Spain. There are currently listeners in 39 different states across our country. Anecdotally we are also hearing that high school students in our diocese are among our listeners!
- We have taken inventory of campus ministry materials currently stored in the diocesan archival area. Backpacks with giveaway items (notepads, pens, travel mugs, etc.) were assembled and distributed to local parishes. These can be used to welcome first-time young adult visitors or to celebrate our existing college students.
- We continue to look for parish involvement with college campuses. In Springfield, St John's Episcopal has continued partnership with Ekklesia, an ecumenical faith organization on the MSU campus. Ekklesia will be opening a new Multicultural House this year, offering student housing in a faith-based community.

2024 Plans for Ministry

- After a brief summer hiatus, *All Things...Episcopal* is starting production on a second season of ten episodes. We anticipate having the first new episode published in October.
- We are gathering information about the history of campus ministry in our diocese. We plan to create a narrative about our background. This will be helpful, not only for future grant applications, but also in determining future goals and objectives for this ministry.
- We are planning to offer a small group class on building bridges during the Lenten season. The class will be taught by Clare Stern-Burbano and will be offered to college students and young adults. Funding for the project has been made available by Interfaith America through a Trinity Wall Street grant program.
- We are exploring options for offering a one-day retreat for college students and young adults at a local parish.
- We are looking for ways to develop partnerships for shared programs with local parishes located near college campuses. We also plan to coordinate with developing youth ministry plans so that we can better serve high school students as they graduate to college and/or the work place.

#### 18. NOURISH KC

## What are the highlights of your ministry for 2023?

• For over 35 years, Kansas City Community Kitchen has provided hot meals to anyone in need. In 2022, we served nearly 188,000 meals, a 28% increase from the previous year. NourishKC completed a survey of over 40 organizations who offer food services in Kansas City and found only two organizations offer dinner that are not overnight shelters, to help bridge the gap between meals for our community, NourishKC provides guests with supplemental meals. In 2023, Kansas City Community Kitchen has prepared and served 126,744 nutritious meals. Of those 126,744 meals, 34,495 were supplemental and 9,127 of them were for outside agencies. Our goal for 2023 is to serve 202,000 meals.

Our programs – Kansas City Community Kitchen and Food Rescue – are supported by our volunteers. In 2022, our programs were supported through 1,300 volunteers who have donated 12,837 hours of their time to fight hunger in our community. NourishKC's food rescue program helps 13 local food donors reduce their annual food waste. Only 30% of our rescued food is used to make healthy meals at Kansas City Community Kitchen. We redistribute the other 70% to 13 pantry partners across Jackson, Johnson, Wyandotte, and Platte Counties. In 2022, NourishKC rescued 521,706 pounds of food from going to waste, a 33% increase from 2021, and plans to increase pounds served to over 750,000 in 2023.

Recent leadership changes emphasize partnerships and data-driven decisions to optimize community services without duplication. In 2022 and 2023, Downtown

Council of Kansas City partnered with NourishKC, Care Beyond the Boulevard, and The Greater Kansas City Coalition to End Homelessness to renovate the upper half of the 8th and Paseo building, creating "The Beehive." This multidisciplinary facility near overnight shelters fosters collaboration between these four organizations. The Beehive provides essential services for individuals and families to transition out of homelessness in one location, officially opening in June and operating Tuesday-Thursday from 11:00 AM to 4:00 PM. It also offers office space for other social service organizations in the KC area. Food serves as a catalyst to connect with the population we mutually serve, allowing Kansas City Community Kitchen guests to access essential services while enjoying a fresh meal. The goal is to extend The Beehive services to Monday-Friday, 11:00 AM to 8:00 PM, with occasional Saturday workshops.

## What are your plans for ministry in 2024?

Plans in 2024 include increasing our community outreach, enlarging our donor and volunteer footprints to reach more corporate groups and partners, and expanding our existing programs to meet the ever-growing need for those experiencing food insecurity in our region

## 19. SPIRITUAL FORMATION COMMISSION

The Spiritual Formation Commission mission is to advocate for Christian formation; explore the needs of our congregations and determine a helpful response; discover resources and recommend 'best practices; assist congregations in the process of incorporating pathways to formation with intention; and if desired, offer training or educational events.

Our goal, to encourage and nurture spiritual growth, Christian practices, and theological reflection, is based on the belief that actively engaging in Christian formation is a transformative experience which affects our understanding of morality, politics, economics, labor, family, the environment, hospitality, justice, friendship, and forgiveness; in short, everything is a spiritual matter.

Throughout 2023 the Spiritual Formation Commission has focused on –

- Curated traditional, experiential resources and best practices for people of all ages on the diocesan website to organize the wealth of online information and simplify the search process.
- Being a companion presence of support, consultation, resources, and encouragement.
- Formation-related posts through the New Spirit Update highlighting resources and reflections.
- Deanery Updates to keep local congregations informed about formational opportunities.
- Small Group Facilitator Training to empower lay leadership to feel knowledgeable about and comfortable with leading small groups.
- Education for Ministry (EfM) and with the addition of a new class this fall the diocese now has two hybrid, and one in-person, seminar groups.
- The August Desert Mother's and Father's Retreat with Rev. Brad Karelius was well attended and will be offered again in soon.
- We have identified human resources and support to congregations in the following areas –
  - Children's and Godly Play Ministries
  - Youth Ministry
  - Young Adult Ministry
  - Education for Ministry (EfM)
  - Adult Formation Resources
  - Retreat Assistance
  - Small Group Facilitator Training
  - o Stephen's Ministry
  - Forma
  - o BKSM

The Spiritual Formation Commission's ministry is to walk with the people of West Missouri as they seek to become authentically engaged in hospitality, worship, prayer, learning and mission; a people who "live out the values of the kingdom of God in the presence of the kingdoms of the world;" ii and a people becoming human beings made in the likeness of Christ.<sup>1</sup>

#### 20. STANDING COMMITTEE

## Meetings

#### Standing Committee of the Diocese of West Missouri Report to the 134<sup>th</sup> Diocesan Convention 2023

The Standing Committee (SC) exists by order of the Constitution of The Episcopal Church. Article IV directs that each diocese shall have an SC elected by the Diocesan Convention, but it assigns the body only two duties: "The Standing Committee shall be the Bishop's Council of Advice," and "if there be no Bishop or Bishop Coadjutor or Bishop Suffragan canonically authorized to act, the Standing Committee shall be the Ecclesiastical Authority of the Diocese." The Canons of The Episcopal Church spell out other responsibilities for SCs, and the Constitution enables diocesan canons to grant SCs further rights and duties (Article IV). With its constitutional tasks to serve as the bishop's council of advice and the ecclesiastical authority in the absence of a bishop, an SC can be seen as a body standing alongside the episcopacy in administering the authority of the Church in that diocese.

The West Missouri SC consists of four priests and four lay persons who are elected by Diocesan Convention to two-year terms, and members may serve three consecutive terms (WEMO Constitution Article XIV.1). Each SC elects its president and secretary (TEC Canon I.12.1). By tradition, West Missouri's SC presidency and vice-presidency rotate between lay and ordained members, such that one of these officers is lay and the other is ordained. The SC president is an ex-officio member of the Diocesan Council (WEMO Canon IX.1.k). To build collaboration between these bodies, the Diocesan Council and SC shall "endeavor to meet in joint session during four (4) of the regular meetings of the Diocesan Council" each year (WEMO Canon IX.9). When the diocese is, or is expected to be, without a bishop for more than three months, the Diocesan Council and SC must meet in joint session at least once during each three-month period (WEMO Canon IX.9). In addition, an SC member serves as an ex-officio member of the diocesan Commission on Ministry (COM).

The SC membership included Dr. Jeremy Chesman; Ms. Alexandra Connors; the Rev. Larry Ehren; the Rev. Ted Estes; the Rev. Anne Kyle, secretary; Ms. Marsha Patterson; Mr. Eric Rhodes, vice president; and the Rev. John Spicer, president. The group has met 16 times since the last diocesan convention.

The 2022-23 SC's actions have fallen into the following categories:

## Collaborating in diocesan leadership

As the bishop's council of advice, the SC has invited Bishop Diane to join us for our monthly meetings. She gives us an update on her work, shares updates from the larger Episcopal Church, shares opportunities or concerns on the horizon, and seeks our input on whatever topics we would like to raise. The bishop and the SC president speak between meetings as needs and issues arise. The SC also meets annually with Bishop Diane for a 360-degree review. Our relationship with Bishop Diane has been genuinely collaborative, a mark of the growing authenticity and depth of relationships among stakeholders across the diocese.

The SC gathered with the Diocesan Council for a retreat in February 2023. The goal was to explore the missional heritage of West Missouri underlying the new diocesan vision and mission statements discerned by Council in January:

*Vision:* God's just and peaceful beloved community built on our shared love of God and one another.

*Mission:* As the Body of Christ, we seek, serve, and save the lost by proclaiming the Good News, forming disciples, serving others, and striving for justice.

In the retreat, we began identifying desired outcomes in each of those four pillars of mission, as well as developing SMART goals (specific, measurable, achievable, relevant, and time-bound) to flesh out the priorities we heard God asking us to pursue. These goals formed the basis of rebuilding the diocesan plan for ministry (budget) from the ground up for 2024.

## Considering consents to episcopal elections in the larger Church

From December 2022 through October 2023, the SC voted to consent to the elections of 11 bishops in The Episcopal Church.

In April 2023, the SC voted not to consent to the election of the Rev. Charlie Holt in the Diocese of Florida. Following the canonical 120-day period for consents, a majority of bishops and SCs of the Church had withheld their consent to Rev. Holt's election.

## Considering consents to candidacy for holy orders and consents to ordination

The SC interviewed and considered consents for 10 persons in the process toward ordination in the diocese. The SC also worked more closely with the COM this year, including sending an SC representative to COM meetings and participating in the COM's Next Steps gatherings with aspirants.

## Considering encumbrances or sales of parish or diocesan property

The SC received no requests to consent to encumbrances or sales of parish or diocesan property in 2022-2023.

# Overseeing the process of electing a new bishop diocesan for West Missouri

In early 2023, exercising its authority under The Episcopal Church's Canon III.11.1.a and the Diocese of West Missouri's Constitution Article IV.1, the SC discerned the Holy Spirit's direction that the time had come for West Missouri to embark on its journey toward calling its ninth bishop. We met with the Rt. Rev. Todd Ousley, bishop for pastoral development, to learn about the bishop-search process and discuss potential consultants to help in the search. Bishop Ousley referred the SC to three consultant candidates, and we selected the Rev. Canon Brian Nordwick, a deacon and past canon to the ordinary in the Diocese of El Camino Real. Canon Nordwick advised us in developing several documents to define and structure our search:

- A timeline for the search, transition, and consecration process.
- Position descriptions for members of the Bishop Search Committee, Transition Committee, and Consecration Committee, as well as for a chaplain to the search process.

- A statement of the SC's commitment to the diocese related to carrying out the search.
- A prayer for the process from search to consecration, for use in all the congregations of the diocese.

Guided by the diocesan chancellor, the SC drafted rules for the election of a bishop diocesan, planned to take place in conjunction with the next Diocesan Convention, Nov. 8-9, 2024.

With diocesan communication coordinator Zach Phillips, the SC also developed a bishop-search website to provide all information related to the search, transition, and consecration process. On Aug. 23, the website went live, as did online applications for service on the Bishop Search, Transition, and Consecration Committees. Applications for the Bishop Search Committee members, as well as chairs of the other two groups, remained open through September. The second week of October, the SC appointed the Bishop Search Committee and the other two committees' chairs; those names were not available at press time for this report but are included elsewhere in the 2023 Convention's materials. On Nov. 17-18, following the election of the 2023-24 Standing Committee at Diocesan Convention, the Bishop Search Committee, the chairs of the other two committees, and the SC members will meet with search consultant Nordwick and assistant consultant the Rev. Shug Goodwin for a retreat to begin the work of the search.

#### Other work

SC members the Revs. Anne Kyle and John Spicer wrote a guide to the work of the Standing Committee, which will be available to help onboard the incoming members elected at this convention.

The full committee meets via zoom with occasional on-site inspection trips conducted by those who are available. This past year the committee met four times and completed the following work:

- Advised a parish regarding mold and ventilation issues.

## 23. ACCESS FOR ALL GOD'S CHILDREN

A year ago this November, Bishop Bruce convened a group of persons living with disabilities to address the need we all have for making our churches accessible and accommodating. Since that time several members of the Diocese of West Missouri have been working to assist the church in providing access for all God's children.

Our team of laypersons and clergy began in mid-November 2022 with five persons convened by Bishop Bruce to address the issues faced by "differently abled" persons. As of this writing there are now eight members, with disabilities, seen and unseen:

David Britt, St James, Springfield; Minda Cox, St Alban's, Bolivar; Rev. Peter DeVeau, Cathedral Dean emeritus; Gin Miller, Cathedral, Kansas City; Rev. Meg Rhodes, St Anne's, Lee's Summit; Rev. Brittany Sparrow Savage, St Paul's, KC; Rev David Wilcox, St Augustine's, KC; Lane Vermillion, Resurrection, Blue Springs.

One of the first things this group did was to find a name for our work that would fully define its breadth. "Access for All God's Children" AGC, seemed to describe best the scope of our work. Each of us has a role in providing access for all God's children. Early on we agreed that we should not be ministering TO others, but WITH others. The main focus of our work is to foster awareness and create a mindset for accessibility throughout our diocese and local communities.

Our work reflects the mind of the larger church:

The Episcopal Church is committed to working for accessibility and civil rights for persons with disabilities. We support the provisions of the Americans with Disabilities Act of 1990, which prohibits discrimination against individuals with disabilities in employment, transportation, and public and private spaces. But, for many with disabilities, the barrier between us and the altar remains physically real even though the church canons state, "No one shall be denied rights, status or access to an equal place in the life, worship, & governance of this Church because of race, color, ethnic origin, national origin, marital status, sex, sexual orientation, gender identity & expression, disabilities or age...." (Canon I.17.5) 2015

Seen and unseen. All manner of human disability is present in our communities. For those living with disabilities, barriers are everywhere.

AGC was recognized at the 2022 Diocesan Convention. Since last November we have met monthly. The consensus is that our Zoom meetings lasting no more than an hour leave us hopeful and energized.

Highlights of our AGC work in our first year

- promoting a Lenten book study of "My Body is Not a Prayer Request: Disability Justice in the Church," by Amy Kenny. Rev Brittany Sparrow Savage guided and inspired this
- developing and submitting a budget Diocesan Council for supporting accessibility initiatives and persons with disabilities.

- ongoing work developing an informational and resource page on the West Missouri website. This page will include helpful links for congregations and individuals to assess and provide for equity in accessibility. We are grateful to Zach Phillips and Eric Rhodes for their support and assistance.
- convening a gathering for persons interested in AGC at St Alban's, Bolivar on Saturday, September 9. This event grew out of our stated desire to build community among those with disabilities and supporting them in their needs. Minda Cox of St Alban's shared her story of living with life-long disability and instructed the group in the fine art of watercolor painting. Titled "I am possible," the workshop included time for sharing of individual challenges and hopes.

Much of the church has forgotten that we worship a disabled God whose wounds survived resurrection, says Amy Kenny. It is time for the church to start treating disabled people as full members of the body of Christ who have much more to offer than a miraculous cure narrative and to learn from their embodied experiences.

## 25. SECRETARY OF THE DIOCESE

It has been my privilege to serve as Secretary of the Diocese and of Diocesan Council since my election by Council on March 4, 2023. Sincere thanks to my predecessor, Curtis D. Hamilton, for his years of committed service as Secretary.

This report will explain the purpose of Diocesan Council, its structure, and the actions taken by the Council since the 2022 Convention to meet its canonical responsibilities.

Article XIII of the Constitution of the Diocese of West Missouri provides in part that Diocesan Council "shall exercise all the power of the Convention between meetings thereof, for the purpose of the unification, development and prosecution of the work of Missions and Church Extension, the development of congregational life, Christian formation and community life, social ministries of the Church and leadership development."

Canon IX, section 4, of the Canons of the Diocese of West Missouri provides that the Officers of the Diocesan Council are a President, a Vice-President, and a Secretary. The Bishop of the Diocese is the President of the Diocesan Council and is the head of all the work of the Diocesan Council. The Diocesan Council elects from its membership a Vice-President, and the Rev. Galen Snodgrass was so elected at the December 20, 2022 Diocesan Council meeting. The Secretary of the Diocese is the ex-officio Secretary of the Diocesan Council.

Canon IX, section 1, of the Canons of the Diocese of West Missouri provides in part that the Diocesan Council is composed of the following members, all with seat, voice, and vote:

the Bishop; the Secretary of the Diocese; the Treasurer of the Diocese; the Chancellor of the Diocese (seat and voice, but not vote); eight laypersons elected by the Annual Convention; four clergy elected by the Annual Convention; four laypersons appointed by the Bishop; the President of the Episcopal Churchwomen, ex-officio; the President of the Standing Committee, ex-officio; the Deans of the Deaneries, ex-officio; and any other Officers of the Diocese, if any (seat and voice, but not vote). The four laypersons and two clergy elected at each Annual Convention and the two laypersons appointed by the Bishop serve for a two-year period. No member of the Diocesan Council may be elected to serve for more than three consecutive two-year terms

  - Mission: We seek, serve, and save the lost by proclaiming the Good News, forming disciples, serving others, and striving for justice.
  - Vision: God's just and peaceful beloved community built on our shared love of God and one another.
- adopted a motion to raise Formation Coordinator Kim Snodgrass's Diocesan credit card limit from \$1,500 to \$3,000 to enable her to cover expenses incurred during the Forma Conference
- adopted a motion that the Diocese use the invoice method of reimbursing the Rev. Angie Tharakan for her actual expenses as supply priest at St. Stevens Episcopal Church, Monet (an Episcopal Churches of the Ozark (ECHO) network congregation) instead of paying the Diocese excess contributions for ECHO above cost

#### February 4, 2023

 adopted a motion to approve the auditor fees of Welsh Associates for the year 2022

#### March 4, 2023

- ratified the action of the Executive Committee in approving \$2,000 from the General Fund for the HVAC system at Church of the Transfiguration, Mountain Grove, to stabilize the building for short-term heating needs
- adopted a motion to approve a future best-choice bid from two or three bids up to \$14,000 to be drawn from the Rust Fund to resolve the HVAC issue at Church of the Transfiguration, Mountain Grove

- agreed that the Four Pillars of Mission (Forming Disciples, Proclaiming the Good News, Serving Others, and Striving for Justice) groups have the responsibility in the Diocesan budget process to match budget requests received with the Pillar group's priorities and rank the items in terms of importance, urgency, value, and make budget recommendations by May 1 to the Very Rev. Isaac Petty
- adopted a motion that the Very Rev. Isaac Petty continue to assist in the 2024 budgeting process after the conclusion of his membership on Council as Dean of the Central Deanery

#### May 13, 2023

- the 2024 Budget-Expenses Only Draft 1 spreadsheet was reviewed, and discussions resulted in the following actions with regard to the figures in the "Group Recommendations" column:
  - o How We Serve Others:
    - adopted a motion that: (a) proposal numbers 23 (CCO) and 29 (Nourish KC) be reduced to \$15,000 each, and the \$30,000 funds saved added to the centralized grant committee for outreach; and (b) proposal number 41 (St. Luke's Carthage) be reduced to zero
  - How We Spread the Good News:
    - adopted a motion that proposal number 4 (Canon for Common Mission) be reduced to zero
    - adopted a motion that proposals numbered 6 (Curacy Program), 11 (Hispanic Ministry – South), 34 (Communications), and 38 (New Community Ministries) be fully funded
    - adopted a motion that proposal number 5 (Shared Ministry Developers) be reduced to \$50,000, with the understanding that parishes with multiple priests and clergy on the supply clergy list will make a commitment to rural congregations to celebrate the Eucharist with those congregations at least once per month
    - adopted a motion that proposal number 38 (New Community Ministries) be reduced to \$50,000
  - How We Form Disciples:
    - adopted a motion that proposals numbered 18 (Clergy Retreats), 22 (Clergy Continuing Education), 30 (Cursillo), 45 (Stewardship Committee), and 51 (Daughters of the King) be fully funded
    - adopted a motion that proposals 17 (Vocations) and 19 (Congregational Development/Transitions) be fully funded
    - adopted a motion that proposal 46 (Youth Ministry) be fully funded
    - adopted a motion that funding for the following proposals be reduced to eliminate funding for hiring new staff:
      - proposals 16, 24, 44 (Campus Ministry) funded at \$8,000
      - proposal 35 (Children's Ministry) funded at \$25,000
      - proposal 47 (Spiritual Formation) funded at \$22,000
  - How We Strive For Justice:
    - adopted a motion that proposals 1 (LGBTQIA+ Committee), 20 (Peace & Justice Committee), 21 (Diversity & Reconciliation), 48

Ecumenical Relations Commission), and 53 (Access for All God's Children) be fully funded

- o How We Support the Four Pillars:
  - adopted a motion that all of the line items under this section be fully funded except that proposal number 49 (Diocesan Archives) be funded as requested at \$9,586
  - adopted a motion that the Diocese terminate the lease on the Springfield apartment when the lease expires on September 16, 2023, with the 60-day notice of termination/non-renewal given in July
  - adopted a resolution authorizing a parsonage exclusion for the Rev. David Wilcox
  - adopted a motion that, considering the current increase in expenses to maintain building and utility costs in the Diocesan office, that the current cost share of office space from our tenant, ELCA, be increased 10% from \$2,000 per month to \$2,200 per month

#### June 17, 2023

- authorized expenditure of up to \$18,000 for roof repair to the Diocesan Center
- adopted a resolution delegating to the Standing Committee President the
  authority to enter into various contracts and agreements on behalf of the Diocese
  in connection with the Standing Committee's canonical obligations for the Bishop
  Diocesan search, effective through the date on which the Bishop Diocesan is
  consecrated; further, the Standing Committee will make a monthly report to
  Council on its activities and expenditures relating to its canonical obligations for
  the search, nomination, transition, and election processes for a Diocesan Bishop

#### July 8, 2023

- adopted a motion to approve a \$10,000 grant from the Congregational Development budget to Trinity Episcopal Church, Independence, to pay for the services of Church Development to help Trinity with its capital campaign
- adopted a motion that the \$10,000 unrestricted gift from the Carolyn Phelps Estate Pooled Income Fund be deposited into the Rust Fund, which has a rural ministry focus

#### August 12, 2023

- adopted a motion that the existing letter of credit to Shepherd of the Hills Episcopal Church, Branson, for roof repair be extended \$6,000 with zero percent interest over a twenty-year amortization to fund the repair of wood beams due to wood rot and for beam repainting
- adopted a motion that, effective immediately, the hours of the Diocese's Human Relations Administrator Elaine Gilligan be increased from sixteen to twenty hours per week with a \$5 per hour increase in pay
- adopted a motion that all Diocesan staff, including the Bishop, receive a 3% cost of living adjustment (COLA) for 2024
- adopted a motion approving the 2024 Minimum Clergy Compensation proposal
- adopted a motion that the Property Maintenance line item be zeroed out in the 2024 operating budget and a separate property maintenance/improvement fund be established in the amount of \$300,000, funded by COVID relief funds currently held in the Expansion Fund, with expenditure of those funds governed by the centralized Diocese grant process

- adopted a motion that a \$50,000 Property Maintenance line item be included in the 2024 budget
- adopted a motion that the \$50,000 New Community line item be zeroed out from the 2024 operating budget
- adopted a motion that the centralized Grant Committee line item in the 2024 budget be reduced to \$100,000
- adopted a motion that the 1.75 full time employee (FTE) Communications staff position be reduced to 1 FTE position and that \$20,000 be allocated in the budget to pay for contract services related to communications
- adopted a motion that the proposed 2024 Plan for Ministry with a \$43,000 deficit be approved

#### September 8, 2023

- approved a motion adopting the following adjustments proposed by the Finance Committee to the 2024 budget (which had a \$51,754 deficit): increases in line items for property insurance and utilities; reductions in line items for assessment underfunding, children's ministry, clergy travel, curacy program, IT & S costs, and legal fees
- approved a motion that the 2024 budget line item for area bookkeepers of \$27,000 be reduced by \$7,500

#### October 14, 2023

- approved the use of Congregational Development funds to pay retroactively for a recent \$2,700 roof repair (not insurance related) at St. Philip's Episcopal Church, Trenton
- approved a \$15,000 line of credit for Christ Episcopal Church, St. Joseph, to be paid back over 36 months for roof and gutter repair (\$9,420) and for construction of a hospitality area (\$2,575)
- granted \$16,915 in assessment relief to St. Mary Magdalene Episcopal Church, Belton, as recommended by the Assessment Review Committee
- granted \$11,781 in assessment relief to Grace Episcopal Church, Liberty, as recommended by the Assessment Review Committee
- accepted the auditor's unqualified opinion ("clean" financial audit report) received by the Diocese for the year ending December 31, 2022
- upon review of the 2024 Plan for Ministry draft for presentation at Convention, the Council:
  - o approved an amendment to the Bishop travel expense line item in the narrative budget under Bishop Provisional personnel cost to reduce Bishop travel, both within and outside of the diocese, to \$18,000, and to add a \$5,000 line item for Bishop hospitality expenses
  - o approved increasing the Clergy Retreat line item in the narrative budget from \$10,000 to \$12,000
  - o approved the dollar amounts and narrative descriptions in the 2024 Plan for Ministry

## 26. YOUTH MINISTRY COMMISSION

The mission of the Youth Ministry Commission and the diocesan youth ministry program is to inspire, educate, and empower young people to live the Good News, marks of which are: truth, hope, justice, mercy, forgiveness, and peace. The commission is chaired by the Rev. Joseph Pierjok and made up of the following members: Alexandra Connors, the Rev. Ted Estes, the Rev. Steven King, Amanda Perschall, the Rev. Isaac Petty, Kim Snodgrass, Clare Stern-Burbano, and Laura Williams. The Rev. David Wilcox serves as staff-liaison to the commission in his role as Diocesan Missioner for Youth Ministry. The commission meets regularly by zoom, and since the last convention, the commission has met approximately seventeen times.

In its current iteration, the Youth Ministry Commission was formed in April of 2022 with the purpose of overseeing the process to call a new diocesan missioner for youth ministry. In this capacity, in consultation with the Bishop, it created a job description, sought candidates, reviewed applications and conducted interviews. In March of this year, they recommended that the Bishop call the Rev. David Wilcox as the Missioner for Youth Ministry. Fr. David began his new role in May of 2023.

Following the Coronavirus pandemic, diocesan youth ministry has been in a period of rebuilding relationships and beginning to equip communities of The Diocese of West Missouri with the resources and tools they need to carry out youth ministry on a local level. Since May, we have partnered with the Episcopal Diocese of Kansas to send five youth to Episcopal Summer Mega Camp at YMCA Camp Wood in Emporia, Kansas, sent a team of four young people and four adults on a mission trip to West Virginia, sent a diocesan delegation of six youth from across the diocese to the triennial Episcopal Youth Event which took place at the University of Maryland and hosted game nights in the northern and southern parts of the diocese. We are looking forward to hosting the diocesan youth gathering which will take place as a lock-in in conjunction with the 2023 Diocesan Convention.

Fr. David has visited a number of churches and met with youth leaders from around the diocese to build relationships and hear about the ministries happening across the diocese and to see how he and the Youth Ministry Commission can best support them.

In 2024 we plan to continue building relationships across the diocese, fostering a sense of community among the youth of the diocese and equipping parishes to minister to youth in their unique contexts. Some upcoming events include Episcopal Summer MegaCamp in partnership with the Diocese of Kansas, a trip to the 81st General Convention of the Episcopal Church in Louisville, Kentucky, service opportunities, regional game nights and a Happening retreat.
