Present: The Bishop, Rev. Dr. Ritchey; Messrs Paul Simonds, B. G. Howard and Rev. R. N. Spencer.

The Bishop made a report on the request of Trinity Parish, Independence Mo. in re their request for an increased appropriation.

It was resolved by the Board that hereafter all appropriations be made to the Treasurer of the parish, mission or station to which granted and not to the missionary. It was further resolved that the payments be made to such parishes, missions or stations only when they are occupied by a missionary of the Board.

The Bishop recommended that the appropriation to St. Augustine's Mission, Kansas City, be discontinued owing to the fact that there was no missionary now in that field.

The Bishop then made the following recommendations for appropriation of missionary funds for the ensuing year, some of which appropriations were to be reduced, by action of the Board as noted:

It was resolved by the Board that every parish or mission to which it makes an appropriation be required to make a statement to the Board of the amount of stipend paid locally, and a monthly report as to whether or not the stipend had been paid up to the last preceding month.

Resolved that the apportionments of the Church of the Good Shepherd, Kansas City and the Parish of Trinity Church, Kansas City be changed on the Treasurer's Books as follows: Church of the Good Shepherd to \$9.75 and of Trinity Church to \$375.00 in accordance with the recommendation of the Board of Equalization, such changes having been made to agree with the Communicant-lists of these respective Churches.

The Bishop announced that the Rev. R. Alan Russell had retired from the diocese.

The Board was called to Order at 10 a.m.
Present: the Rt. Rev. the Bishop; The Rev. C. Hely Maloney; the Rev. Dr. Ritchey; the Rev. C. A. Weed; the Rev. R. N. Spencer; Archdeacon Johnson and Mr. B. C. Howard. The minutes of the last meeting were read and approved. The Treasurer read his report after which it was resolved to request the Bishop to present the claims of the Board to certain congregations who were delinquent in their missionary apportionments. The congregations specified were those of Christ Church, Springfield; St. John's Church Springfield; Christ Church, Bonville, and Grace Church, Carthage. The Bishop was requested to report to the Board what might be expected from these congregations.

The Secretary was instructed to send a letter, the form being prescribed by the Board, to the following missionaries, The Rev. Carl Reed Taylor, missionary at St. John's Kansas City and at Liberty and the Rev. R. C. Talbot at Marshall, calling their attention to the fact that these missions are receiving appropriations from the Board and that a return of at least 10% in missionary giving is expected from them.

The Board adjourned for luncheon provided by the Woman's Auxiliary of St. George's Parish for which hospitality the Board passed a vote of thanks, the Bishop conveying the same to the ladies.

After which a detailed discussion of the Treasurer's report was taken up.

It was resolved to charge off the Treasurer's Books all delinquencies of Holy Trinity Church, St. Joseph preceding the last Council.

The Rev. C. A. Wood moved that the above action be taken in respect to delinquencies of all parishes and Missions. After some debate, the motion was laid upon the table.

It was resolved that the Treasurer prepare a blank to be sent to all Stipendiaries of the Board requiring a report of local stipend and whether or not it had been paid to date.

It was resolved that the amount of \$ 25.00 per month be paid to the Bishop for maintaining services at St. Augustine's Mission from the time its former Missionary vacated it, and so long as the Bishop provides services, said appropriation being the General Board's provision for that work.

Resolved that the Board appropriate the sum of \$ 100 per year to Savannah and \$ 300 per year to St. Luke's Mission, South St. Joseph, such appropriations to begin with the appointment of a Missionary to these places.

The Board reconsidered its former action in regard to the Archdeacon's Expenses and the Archdeacon was instructed to present hereafter a memorandum of his expenses at the close of each month, the Treasurer to give a check for the expenses to the Archdeacon.

The Board resolved to hold a Missionary Rally of the Sunday Schools of Kansas City

on Whit Sunday after noon, and a Committee consisting of Rev. R. N. Spencer, the Rev. J. D. Ritchey, D.D. and Mr. B. C. Howard was appointed to arrange details of the same.

Resolved that a committee be appointed by the Bishop to arrange a meeting of the Churchmen of the Diocese and secure speakers to stimulate the work of Church Extension in the diocese. The Bishop appointed the Committee as follows: Mr. A. C. Stowell; Maj. Alex. Davis; Mr. B. C. Howard, Dr. Ritchey and Rev. R. N. Spencer.

The Board adjourned subject to the call of the Bishop.

The Board of Church Extension met at the call of the Bishop, there being present the Bishop; Archdeacon Johnson; Rev. J. D. Hitchey, D.D.; the Rev. C. Kelly Malony; Rev. R. N. Spencer; Mr. J. A. H. Garlicks and Mr. B. C. Howard, Treasurer.

The minutes of the preceding meeting were read and approved.

The Treasurer read his report which was discussed at length by the Board.

The Committee on the Missionary Rally reported that the Rally was held in Grace Church on the afternoon of Whitsunday, the congregation filling the Church. Stirring addresses on the missionary work of the diocese were made by the Bishop and by the Rt. Rev. the Bishop of Springfield.

The Committee on a meeting of the Church men of the diocese reported that the meeting was postponed until some time in the fall, owing to inability to secure the desired speakers. The report was accepted and the Committee continued.

The Bishop presented an appeal from St. Mark's Church, Kansas City, requesting the

Board to make an appropriation to aid in carrying on the work of that Parish. It was resolved by the Board that, in view of the present financial condition of the Board, it would be unable to make any additional appropriation at this time.

The Board requested, through the Bishop or Archdeacon, the Rev. Mr. Talbot of Marshall to go to Slater and investigate conditions there, the Board agreeing to pay his R.R. and hotel expenses on such mission.

The Board adjourned subject to the call of the Bishop.

A quorum being present, the minutes of the previous meeting were read and approved. The Committee on a meeting of the Churchmen of the ~~City~~ Diocese in behalf of Missions reported that the date had not been arranged. The Committee was continued.

The Treasurer read his report showing a deficit of approximately \$1300.⁰⁰ toward the stipends of Missionaries. After considerable discussion the Board decided to bring the deficit to the attention of the Diocesan Council and ask for relief of the situation, as the Board was unable to make a loan to relieve it.

The Board ordered the Treasurer to correct an error in the apportionment of Christ Church, St. Joseph changing the figures from \$739.20 to \$656.25 which was their proper assessment.

A request from the Rev. J. V. Plunkett asking for additional work with corresponding additional appropriation was not granted, owing to the condition of the treasury.

The Board adopted the Church Pension Fund as regards its missionaries subject to the approval of the Synod by the Diocese of Missouri.

The Board resolved that all delinquencies prior to Nov. 1st 1914 should be charged off the Treasurer's books but that all delinquen-

cies of the current-year be read and posted at the Annual Council.
The Board adjourned subject to the call of the Bishop.

The Board of Church Extension met in Grace Church Parish House Friday Dec. 3d at 2:30 P.m. Present: The Bishop, Dr. Ritchey, The Rev. C. Hely Malony, Archdeacon Johnson, The Rev. L. A. C. Pitscaithley, Maj. Davis, Mr. B. E. Howard.

The Secretary being absent, Rev. L. A. C. Pitscaithley was elected Secretary pro tem. The minutes of the previous meeting were read and approved.

The Treasurer read his report. Archdeacon Johnson addressed the meeting explaining his coming to the diocese on the promise of the late Bishop Atwill to provide \$1000 per annum toward his salary the balance to come from the Board of Missions in New York. He explained the difficulties under which his work had been done but felt that it had been well done and that progress had been made and that the future was bright.

In the discussion of the Board's work, Maj. Davis requested that a map showing the diocesan work be provided for the meetings of the Board. The Bishop said such map would be provided.

A committee consisting of Mr. B. E. Howard, Rev. E. J. Craft and Rev. R. W. Spencer was appointed to draw up a form of report, said report to cover such information regarding the missionaries and their respective fields as would be

useful to the Board in its work. It was ordered that this report be sent to each missionary with his check and that he be advised that no future check would be sent until such report, properly filled out, ~~is~~ returned.

The Board then made the following appropriations, for 90 days only, as suggested by the Bishop. The rate given being the annual rate:

Jan. 18, 1916

The Board of Church Extension met at Grace Church Parish House Tuesday, Jan. 18th at 2 pm. Present: The Bishop, Rev. J. D. Ritchey, D.D., Rev. C. Hely Molony, The Archdeacon, Rev. E. J. Craft, Rev. L. G. C. Pitcaithley, Maj. Alex. M. Davis, Mr. B. E. Howard and Rev. R. N. Spencer. The Bishop invoked the divine blessing. The minutes of last meeting were read and approved. The Secretary explained that a delay in printing had necessitated the post ponement of the Special Meeting to consider Missionary reports. The Rev. E. J. Craft, Mr. B. E. Howard and the Rev. R. N. Spencer were appointed a Committee to prepare a statement on the Missionary reports. The Treasurer read his report which was then subject of discussion.

Maj. A. M. Davis made a report for the Diocesan Missionary Committee, Auxiliary to the Board of Church Extension. The Report stated that several meetings had been held and that the sum of \$577.50 had been collected and applied to the deficit in the Board's treasury. The Report further stated that it was the Committee's intention to issue a pamphlet of information on Missionary affairs in the diocese and circulate same.

It was moved by the Rev. Dr. Ritchey that the Report of Maj. Davis be accepted, that the Committee Auxiliary be heartily endorsed in its action in publishing the pamphlet of information and that a draft be made

on the treasury of this Board printing, postage etc. Carried

The Board, on motion of Maj. A. M. Davis, approved the action of the Treasurer in depositing two bonds second mortgage left by Mr. J. E. Horton in the H. E. Elevated Ry, the action being taken in order to participate in the reorganization of the Company. Carried.

In the matter of appropriations it was ordered that the Secretary of the Board be and he is hereby instructed to notify the Rector, the Rev. John V. Phibbett and the Vestry of Trinity Parish, Independence that the appropriation for work at Independence will not be continued after April 1st 1916. It was further Resolved that it is the sense of this Board that whenever appropriations shall be withdrawn from all places served by any Missionary such action shall be understood as having the effect of removing the name of such Missionary so affected from the list of missionaries of this Board.

It was Resolved that the ~~the appropriation~~ ^{stipend} to St. Mary's Mission Savannah be reduced from \$12.50 to \$5.00 per annum.

The Treasurer was authorized to pay all Missionary stipends according to present appropriation until further action be taken.

The Board adjourned to meet at Grace Church at 10 am Tuesday Feb 15th 1916.

Present: The Bishop, Rev. E. Craft; Rev. C. Hely Molony, Rev. G. A. C. Partridge, Archbishop Johnson, Rev. R. M. ... Mr. E. C. Hammill. Prayers were said by Bishop Partridge. The Minutes of the previous meeting were read and approved. The Treasurer being absent the order of his report was passed over, and the Secretary read a letter from the Rev. J. V. Plumbett in regard to the action of the Board Jan 18 1916 withdrawing the appropriation to Trinity Church Independence after April 1, 1916. By resolution of the Board; the Secretary was instructed to advise the Rev. Mr. Plumbett that his letter of Feb. 16 1916 had been received and duly laid before the Board and that after careful consideration the Board had reaffirmed its action of Jan 18, 1916, in withdrawing the appropriation to Independence on and after April 1, 1916.

The Bishop addressed the Board in behalf of the Rector of St. Mark's Church, Kansas City, who desired work and an appropriation from the Board to augment the salary paid him

by St. Mark's Parish. It was Resolved that it was the sense of the Board that in the present location of St. Mark's Church, the Board would not feel it wise to offer to the Rector additional work in order to augment his stipend.

It was Resolved that it was the sense of the Board to appropriate the sum of \$750.00 per annum for the Commission year only, as a stipend for a General Missionary for the Eastern portion of the Northern Diocese contingent upon that field raising a like amount or more. The Board then adjourned.

The Board of Church Extension met at Grace Church Parish House Kansas City Mo., March 21 1916 at 2 P.M. Present: The Bishop, Rev. J. D. Ritchey, Rev. E. J. Craft, Rev. C. Hely Malony, Rev. R. N. Spencer and Mr. B. G. Howard.

The minutes of the preceding meeting were read and approved.

The Bishop reported that the offer of ^{position as} General Missionary in the eastern portion of the Northern Draney with stipend from the Board of \$750.00 for the year had been declined by the Rev. E. C. Johnson. The Bishop read a proposed pamphlet of Missionary Information to be published by the Wisconsin Missionary Commission which was heartily approved by the Board. It was ~~decided~~ ^{resolved} and carried that the Treasurer borrow on behalf of the Board the sum of \$750.00 to reimburse the Bishop for stipend to that amount advanced to Rev. E. C. Johnson up to March 31st 1916.

A letter from the Rev. J. V. Phinckett of Independence protesting against the Board's action in withdrawing appropriation from Independence was read and ordered filed by the Board.

On invitation of the Rev. C. Hely Malony to meet in St. Joseph the Board adjourned to meet in St. Joseph, Tuesday after Easter, April 25th at 10:30 a.m.

The Board of Church Extension met in Christ Church Parish House Tuesday, April 25th 1916 at 10:30 a.m., having previously attended a celebration of the Holy Communion in Christ Church. After the invocations by the Bishop the roll was called and the following members were found to be present: The Bishop, the Rev. Messrs J. D. Ritchey, E. J. Craft, C. Hely Malony, L. A. C. Pitcaithley, R. N. Spencer, and Messrs B. G. Howard and Alex. M. Davis.

The minutes of the previous meeting were read and approved. The Secretary read the resignation of Mr. Edward C. Hamill from the Board, which was accepted.

The Treasurer then read his report, discussion of which occupied the Board until the noon recess.

It was ordered that the Treasurer reimburse the Bishop for the proportionate sum of Archdeacon Johnson's travelling expenses up to and including the date of the last council.

Of these expenses the following report was made: "The Bishop and Treasurer respectfully report to the Board of Church Extension that they have availed the amount of the Archdeacon's travelling expenses up to the time of the last Council at \$7.33 per month and that the amount in full is \$73.³⁵ and under the Board's resolution of this morning, the Treasurer will repay the Bishop this amount. The Board of Church Extension met in Grace Church Parish House, Kansas City, Mo., May 23^d 1916, at 2:30 pm. Present the Bishop; the Rev. J. D. Ritchey, D.D., the Rev. E. J. Craft; the Rev. L. A. C. Peacock, the Rev. R. N. Spencer, Mr. B. C. Howard and Major Alex. M. Davis.

The minutes of the previous meeting were read and approved. The Treasurer reported that he had the sum of \$171.⁴⁵ on hand with all salaries paid to date and the only obligations being salaries to accrue and a note at the bank of \$750.⁰⁰

The Board authorized the Bishop to arrange the transfer of the Rev. W. S. O. Lamont from St. Joseph to the mission at Trenton and Plattsburg and made appropriations at the rate of \$400 per year to each place from August 1st to date of Council; provided, however, that a Committee from each of these places enter into contract with the Board of Church Extension to pay the sums of \$400 and \$500^{per annum} respectively to the missionary, same to be paid monthly.

Major Davis reported for the Auxiliary Committee as follows: With Mr. Paul Simonds he had visited Joplin and Carthage addressing Sunday Congregations in both places. Mr. Simonds also made addresses on the missionary work. They had been assured at both Joplin and Carthage that the apparatus into would be met in fall. Major Davis reported the intention of himself and Mr. Simonds to go to Sedalia in the

near future and that Messrs Golden and Forbes would visit Chillicothe. A visit to Springfield is also contemplated.

The Board proceeded to fill the vacancy in its membership occasioned by the resignation of Mr. Edward C. Hamill. Mr. J. E. Davidson of Christ Church Parish, St. Joseph was nominated and there being no other nominations Mr. Davidson was unanimously elected member of the Board.

The Rev. L. A. C. Pitcaithley reported for the Committee on a site for a new mission that the corner of 38th and Agnes and the corner of 37th and Monroe were desirable and strategic points. The Bishop requested as many members of the Board as possible to meet with him Wednesday June 28th at 4 pm to inspect these sites.

The Board heard a report from the Committee of the Mission in Webb City, of progress in that field. While the Board felt that its appropriation to Webb City was at the limit of its present resources, it resolved to speak with favor of an increase to the incoming Board.

The Board passed the following resolution: Resolved that at the end of two successive years the Committee of any Mission in the diocese shall report to the Bishop that the best interests of the Church demand a dissolution of the relationship between the Missionary and the mission, the

Missionary shall be given notice of the severance of such relationship to take effect at the end of six months from date of such notice. It was further resolved that information of this policy of the Board be furnished to every incoming Missionary.

It was resolved that the regular meetings of July and August be omitted, and that the Board meet on Sept. 19th, unless specially called together by the Bishop.

The Bishop invoked the Divine blessing on the work of the Board. The minutes of the preceding meeting were read and approved.

The Bishop ~~recommended~~ ^{recommended} to the Board the Rev. J. C. Van Vorst of Colorado Springs, Colorado, to be missionary in charge of the colored work in Kansas City, Mo., with headquarters at St. Augustine's Mission, of which he is to be entitled the Rev., the Vicar, and also to the charge of the colored work in St. Joseph. The Board approved the recommendation, and the Rev. Mr. Van Vorst became a missionary ~~of~~ of this Board.

The Bishop recommended to the Board the Rev. E. B. Wilcox of St. Smith, Arkansas, to be missionary of this Board at Webb City and Neosho and parts adjacent, said relationship to begin on the first day of October 1916. The Board approved the recommendation.

The Bishop reported that the Kansas City branch of the Woman's Diocesan Society had pledged the sum of \$1500 annually for the support of a missionary and to apply on his work in the Ozark territory. It was resolved that the Board of Church Extension should gratefully accept this sum

of \$1500. per year and that it be used for the support and work of a missionary in the Ozarks with headquarters at Lebanon, Missouri. It was resolved to request the money to be paid monthly in advance.

A Committee from the Kansas City Clerics offered the services of its members to be used by the Board for work in the unoccupied places. The Rev. McMolony offered the following resolution: Resolved, that the Board has heard with pleasure that the members of the Kansas City Clerics ~~had~~ offer their services and that a ~~schedule~~ ^{schedule} be prepared by the Bishop in consultation with the Kansas City Clerics whereby these services may be utilized.

NATION WIDE CAMPAIGN COMMITTEE.

Pursuant to the resolution of the meeting of the Board of Church Extension, on February 10th, the Board with other designated persons from the Woman's Auxilliary and the Woman's Diocesan Society met as the Committee of the Nation Wide Campaign on Tuesday, February 28th, at 3:30 P.M. at Grace and Holy Trinity Church.

Those present were:- The Bishop, Rev. R. N. Spencer, Rev. E. J. Craft, Rev. B. M. Washburn, Rev. C. Hely-Molony, Rev. E. W. Merrill, Rev. E. F. Wilcox, Mr. A. C. Stowell, Mr. F. A. H. Garlicks, Mr. F. A. Simonds, Mrs Eugene S. Clark, and Miss Louise Howard.

The Bishop invoked the Divine Blessing.
The minutes of the previous meeting were dispensed with.

Mr. P. A. Simonds gave a verbal report of the work of the Committee on the Nation Wide Campaign in 1921.

On motion of the Rev. Mr. Washburn, the Secretary was instructed to send to the officials of every Sunday School in the diocese a notice that the mite-boxes provided by the General Board be used and that the offering thus gathered be devoted to the general mission of the Church and sent, after Easter, to Mr. B.C. Howard.

It was ordered on the motion of Mr. Simonds, that the Secretary be instructed to arrange a meeting, not to exceed 15 days from date, to which should be invited at least one layman and one laywoman from each parish and congregation in the diocese at the expense of the Committee, to discuss past experiences and present plans for the Nation Wide Campaign. It is recommended that the meeting be after a luncheon.

On motion of the Rev. Mr. Spencer, it was recommended that the distribution of Campaign literature- Church at Work and Exchange of Methods- be referred for re-adjustment to the office of the Secretary.

On motion of Mr. Simonds, the chair was instructed to appoint Mr. A.C. Stowell as Executive Chairman of the Nation Wide Campaign Committee, with authority to add one or two other members as an Executive Committee.

On motion of the Rev. Mr. Craft, the Committee made request of the Board of Church Extension to appropriate a sum- not to exceed \$1,000.00 for the expenses of the current year.

On motion of Mr. Craft the meeting was adjourned.

NATION WIDE CAMPAIGN COMMITTEE.

On the call of The Bishop, the committee met at 4 P.M. o'clock on Tuesday, April 25th, in the Board of Directors Room of the Fidelity Trust Company.

Those present were:- The Bishop, Rev. E. J. Craft, Rev. C. Hely-Molony, Rev. R. N. Spencer, Rev. B.M. Washburn, Rev. E. F. Wilcox; Messrs A. C. Stowell, F. A. H. Garlich, and B. C. Howard.

The minutes of the previous meeting were dispended with.

The purpose for the meeting was stated to be the consideration of the 'Askings' of the Diocese of West Missouri for the next Triennium period, as sent on by the Presiding Bishop and Council, the return of which was necessary, with proper diocesan ratification, at the earliest possible date.

On motion of Rev. Mr. Craft, the committee decided to consider the Items submitted by the P.B. and C/ separately.

On motion of Rev. Mr. Washburn, the committee approved the item of \$10,000 for church plant in South St. Joseph.

On motion of Rev. Mr. Craft, the asking of \$25,000 for the new Church and Parish House for St. Augustine's, Kansas City was approved.

On motion of Rev. Mr. Craft, the committee included in the budget the item of \$100,000 for the new Church Center at the University of Missouri; ~~the P.B. & C. having approved the amount and offering to recommend that the General Church assume \$80,000 of that amount- half to be credited to this diocese:- with the understanding that the two diocese agree upon the proper division of the remainder, the P.B. & C. suggesting that the share of this diocese be \$15,000, that of the Diocese of Missouri to be \$25,000.~~

On motion of Rev. Mr. Washburn, the item of asking for addition to parish house of Grace Church, Carthage ~~was omitted.~~

On motion of Rev. Mr. Craft, the item of asking for aid in building parish house for Calvary Church, Sadalia was omitted.

The instructions from the P.B.&C. showing that the sum of \$100,000 had been allotted to this diocese for askings, the committee discussed new projects.

On the motion of Rev. Mr. Washburn, the committee authorized the following new 'askings:-

- For St. Matthias', St. Joseph--\$12,500 for new Church
- For St. Luke's, Excelsior Springs--\$9,000 for new Church
- For The Ozark Field, centering in Lebanon,--\$7,500 for house for women workers.
- For St. Mary's, Kansas City--\$6,000 for church hall for work in East Bottoms.
